#### A Message from the Leet Township Board of Commissioners

Autumn is in the air as we prepare for cooler days ahead. Halloween Trick or Treat Night will be on Tuesday, October 31<sup>st,</sup> from 6:00 to 8:00 PM. Don't forget to turn your clocks back one hour on Sunday, November 5<sup>th</sup>. We hope you find the following articles helpful and informative.

The first article in this Newsletter is from the Township's volunteer Emergency Management Coordinator, Dave Volk. **This is crucial to your and your family's safety and well-being.** It will be worth your while to read it and make sure Edgeworth Water Authority has your up-to-date contact information so you can be notified immediately in the event of water main breaks and boil water advisories. Likewise, Leet Township also needs to have your contact information so we can quickly notify you of critical situations like flooding and crime alerts from the Police Department.

Leet Township has a new emergency reverse 911 call system: RAVE ALERT. To sign up to receive emergency messages via phone and email, you may visit leettownship.org and click on the RAVE ALERT widget located on the sidebar of the homepage. Follow the prompts to register. Please create a new Rave Alert Account even if you are registered with Swift 911. Receiving alerts through text messaging is not available at this time but will be in the future.

## Reverse 911 Calls and Public Safety

At the end of July this summer, you probably remember Edgeworth Water had a "Boil Water" advisory due to a water main break. Most Leet Township residents got an automated phone call or text about it, but not everyone. Our household didn't get the notice, and several neighbors didn't as well.

I stopped by the Edgeworth Water office and found the contact information they had on file for us was our old landline number that we killed years ago. I gave them our updated information, including everyone in the household's cell numbers and we started getting information from the Edgeworth Water reverse 911 call system the same day.

From what I learned, the Edgeworth Water "Boil Water" advisory was required due to the water line break and the likelihood of contamination was very low. Still this incident emphasized the importance of the 911 call systems we have in the Quaker Valley area and the need to make sure these systems have up to date contact information.

A reverse 911 system is a public safety technology that uses a database to communicate to a defined geographic area. These systems can deliver messages via telephone, text, email, or all three. Residents in Leet Township should be on system from Edgeworth Water, Leet Township, and Quaker Valley Schools district if they have children attending. In Leet Township we use our system to alert residents of possible flooding, road closures, and any kind of emergency that people need to know about.

I highly recommend everyone that needs to get this kind of information in your household be signed up with at least their cell phone numbers. These systems are confidential and your contact information in the databases is not used for any purpose other than for important notifications. Leet Township's system is being upgraded as we speak and information about how to sign up or check your information will be on the Leet Township website very soon. For Edgeworth Water you can go to their website, call, or stop by the office. The website is <u>www.edgeworthwater.com</u> and there is an "Update Contact Information" button on the right side of the home page. The phone number is 412-741-5100.

As I've mentioned before in this newsletter, the basic principle of emergency management is that preparation, response, and recovery to an emergency starts at the home level then can escalate to the local public safety level, then county, state, and even federal levels. So, it's important to be as prepared as possible at the home level by making sure your household members are signed up for these reverse 911 systems so they get critical information.

#### Fair Oaks Sidewalk Replacement Initiative

This fall, Leet Township will replace portions of the sidewalks located on Orchard at the intersection of Beech Street and then continue down a part of Beech Street on both sides. The Township was awarded grant funds from the Community Development Block Grant for this project. This grant was applied for and administered by the Quaker Valley Council of Governments (QVCOG). Excaliber Construction won the bid and will start the project at a date to be determined. Residents will be notified of the start date for this project.

The Township has applied for more grant funds to continue the sidewalk replacement initiative.

## **Recent Animal Complaints**

Recently, the Township Office has received several complaints about barking dogs.

Please be kind to your neighbors by refraining your dogs from barking incessantly, and to prevent the police from knocking on your door. Leet Township Ordinance Chapter 2 says:

#### Part 1. DOGS CAUSING NOISE DISTURBANCES § 2-101. Prohibited Conduct; Violations and Penalties.

If any owner or person in control of a dog, upon receiving written notice from the Township of Leet Police Department that their dog is disturbing the peace and quiet of reasonable persons within the neighborhood by repeatedly barking, fails to stop said disturbance within 24 hours after receiving said notice, then said owner or person in control is in violation of this Part and may be cited by the Police Department or the Township's Animal Control Officer if one is designated and, upon conviction thereof, shall be sentenced to pay a fine of not more than \$1,000 plus costs and, in default of payment of said fine and costs, to a term of imprisonment not to exceed 30 days. Each day that a violation of this Part continues shall constitute a separate offense.

#### Dogs and Cats at Large

Leet Township Ordinance 2002-03 prohibits dogs and cats from running at large in Leet Township. Please make sure that your dogs and cats are always under your control. Violation of this ordinance is a summary offense and carries strict penalties.

### Leet Township Code Enforcement

Leet Township adopted and follows BOCA Property Maintenance Code to establish rules and regulations for maintaining all structures, including administration, enforcement, and penalties of the code.

The code concerns sanitation, grading and drainage, sidewalks and driveways, weeds, accessory structures, and motor vehicles.

Leet Township does not allow unlicensed or inoperative vehicles to be stored on any premises, and at no time should a car be in a state of major disassembly, disrepair, or in the process of being stripped or dismantled unless in an enclosed structure or area designed for that purpose.

All exterior properties are to be kept clean, safe, and sanitary. No garbage or bulky waste should be accumulated on the property.

Grass and weeds should be maintained. Hedges should not block the view of oncoming traffic. Yard waste shall not be accumulated and stored on the property.

Accessory structures, including garages, fences, and walls, should be structurally sound and in good repair.

Sidewalks must be kept free from hazardous conditions such as snow and ice.

Dead and dying trees can harm those walking or driving below them. Please have the trees removed before a problem arises.

All alterations to your property require a permit. Please do not start a project, grade, or bring in fill without talking to the Manager first. It's much cheaper to obtain the proper permit than to make a court appearance for failure to do so.

# **Curbside Leaf Removal Service**

Public Works will begin curbside leaf pick-up the week of October 10th and continue until the week of December 6th, weather permitting.

We ask residents to place their leaves in rows as close to the roadside as possible. Please avoid piling leaves by mailboxes, underneath trees and shrubs, near yard ornaments, and decorations, or in any other hard-to-reach places, as they may not get picked up.

Please <u>do not</u> mix grass clippings, mulch, sticks, or any other yard waste in the piles! It can damage our equipment and shut us down for unnecessary repairs and maintenance. We will not pick up leaves from hard-to-reach areas, or if they contain any yard waste/debris. If this situation occurs, please check that your pile is in a good location for pickup and/or remove any debris so we can get it the next time we come around.

Feel free to bag up grass clippings or other yard waste and place it out for regularly scheduled garbage pick-up. If you use a contractor for yard maintenance, please advise them of our policies. Thank you!

Leet Township Clean Stormwater Initiative

Recently, during our 2023 MS4 stormwater program survey and tests, we encountered a few outfalls in the Fair Oaks neighborhood and Leet Acres area that contained detergents and chlorine.

While the numbers were just a trace amount, the Public Works Department would like to take this opportunity to remind all our residents that when "It Rains, it Drains."

Using local car washes is the best course of action to keep soaps and detergents out of our watershed if possible. Also, remember that draining swimming pools into catch basins hurts our environment and is ILLEGAL.

We strive to keep our streets and community as clean and litter-free as possible. Please remember that what goes into our storm sewers affects our environment!
