The Reorganization Meeting of the Leet Township Board of Commissioners was called to order at 6:00 p.m. by Manager Betsy Rengers at the Leet Township Municipal Building, 194 Ambridge Ave., Fair Oaks, PA 15003. NOMINATION FOR PRESIDENT OF THE BOARD

Ms. Rengers opened the floor for nominations for the President of the Board of Commissioners.

Nomination: Mr. Zimmer nominated Mr. McDaniel as President. Mrs. Adipietro seconded the nomination.

There were no further nominations.

MOTION: Mr. Zimmer made a motion to accept the nomination of Martin C. McDaniel for the position of President, seconded by Mrs. Adipietro, with all in favor of the motion.

Ms. Rengers turned the meeting over to President McDaniel.

President McDaniel welcomed new commissioners Paul Magee and Jessica Cindrich. He stated that the commissioners, manager, and chief had worked well together over the past few years. He was proud of the many accomplishments made over the past several years and thanked Engineer John Valinsky for the grant work he had done. He informed the Board that their role is legislative: to make policies, pass laws, adopt budgets, and levy taxes. A commissioner does not have the authority to act alone. President McDaniel will establish committees, and he asked the board members to email him to indicate which committee they would like to serve on. When issues arise, the commissioners may refer them to the appropriate committee for review and consideration, and they may consult with the president, manager, chief engineer, and/or solicitor. He is considering establishing an ad hoc committee because the fire department is contemplating a consolidation merger with Bell Acres and Leetsdale. He will assign committees at the January 12th regular meeting.
